90.05 PERMIT REQUIRED. (Before connection with public water system.)

90.06 FEE FOR PERMIT. Before any permit is issued, the person who makes the application shall pay twenty-five (\$25.00) to the Clerk to cover the cost of issuing the permit and supervising, regulating, and inspecting the work.

90.11(1) TAPPING MAINS. (Fee.) The tapping fee is one hundred fifty dollars (\$150.00), plus the cost of materials (\$100.00).

BUILDING SEWERS & CONNECTIONS:

96.02 PERMIT FEE AND CONNECTION CHARGE. The person who makes the application shall pay a fee in the amount of ten dollars (\$10.00) to the Clerk to cover the cost of issuing the permit and supervising, regulating, and inspecting the work. In addition, there shall be a connection charge in the amount of two hundred fifty dollars (\$250.00) for a single-family residence. For multiple dwelling units, the connection fee shall be two hundred fifty (\$250.00) for the first dwelling unit and one hundred dollars (\$100.00) for each additional dwelling unit. The minimum sewer connection fee for commercial establishments shall be five hundred dollars (\$500.00)...
