

CITY OF HAMPTON - FIREWORKS PERMIT APPLICATION

IN ACCORDANCE WITH CITY ORDINANCE 41.12

41.12 FIREWORKS. The use or exploding of fireworks within the City are subject to the following:

1. Definition. The term "fireworks" includes any explosive composition, or combination of explosive substances, or articles prepared for the purpose of producing a visible or audible effect by combustion, explosion, deflagration or detonation, and specifically includes blank cartridges, firecrackers, torpedoes, skyrockets, roman candles, or other fireworks of like construction and any fireworks containing any explosive or flammable compound, or other device containing any explosive substance. (Code of Iowa, Sec. 727.2)

2. Regulations. It is unlawful for any person to use or explode any fireworks; provided the City may, upon application in writing, grant a permit for the display or fireworks by a City agency, fair associations, amusement parks and other organizations or groups of individuals approved by City authorities when such fireworks display will be handled by a competent operator. No permit shall be granted hereunder unless the operator or sponsoring organization has filed with the City evidence of insurance in the following amounts: A. Personal Injury: - \$250,000.00 per person. B. Property Damage: - \$50,000.00. C. Total Exposure: - \$1,000,000.00 (Code of Iowa, Sec. 727.2)
