

ORDINANCE NO. 303

AN ORDINANCE FOR ADOPTION OF THE INTERNATIONAL PROPERTY MAINTENANCE CODE AND THE REPEALING OF CHAPTERS 145 DANGEROUS BUILDINGS, CHAPTER 152 BUILDING CODE , SECTION 50.02(9) AND CHAPTER 153 RENTAL HOUSING CODE OF HAMPTON MUNICIPAL CODE

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF HAMPTON, IOWA:

An ordinance of the City of Hampton, Iowa adopting the 2006 edition of the *International Property Maintenance Code*, regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use, and the demolition of such existing structures in the City of Hampton; providing for the issuance of permits and collection of fees therefore; repealing Section 50.02(9), Chapter 145 Dangerous Buildings, Chapter 152 Building Code and Chapter 153 Rental Housing Code of the Municipal Code of Hampton and all other ordinances and parts of the ordinances in conflict therewith.

The City Council of the City of Hampton does ordain as follows:

Section 1. That a certain document, three (3) copies of which are on file in the office of the City Clerk of the City of Hampton, being marked and designated as the *International Property Maintenance Code*, 2006 edition, as published by the International Code Council, be and is hereby adopted as the Property Maintenance Code of the City of Hampton, in the State of Iowa for regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use, and the demolition of such existing structures as herein provided; providing for the issuance of permits and collection of fees therefore; and each and all of the regulations, provisions, penalties, conditions and terms of said Property Maintenance Code on file in the office of the City of Hampton are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section 2 of this ordinance.

Section 2. The following sections of the adopted International Property Maintenance Code, 2006 are hereby revised:

Section 101.1. Insert: City of Hampton

Section 103.5. Insert: See related fee schedule in “Rules and Procedures”

Section 302.4. Insert: Allowable height of grass shall be 6” (inches) in developed Residential, Commercial and Industrial zoned districts. Allowable height of grass shall be 12” (inches) in undeveloped Residential, Commercial and Industrial zoned districts.

Section 304.14. Insert: March through November

Section 602.3. Insert: January through December

Section 602.4. Insert: January through December

Section 3. That Section 50.02(9) of Chapter 50, Chapter 145 Dangerous Buildings, Chapter 152 Building Code and Chapter 153 Rental Housing Code of Municipal Code of Hampton and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Hampton City Council hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

Section 5. That nothing in this ordinance or in the Property Maintenance Code hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 6. That the Hampton City Clerk is hereby ordered and directed to cause this ordinance to be published. (An additional provision may be required to direct the number of times the ordinance is to be published and to specify that it is to be in a newspaper in general circulation. Posting may also be required.)

Section 7. That this ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect upon publication in the Hampton Chronicle.
